We agree a fee with you prior to commencing any work, which is calculated based on our hourly rate. Work on your matter may sometimes be carried out by more than one fee earner, which is taken into consideration at the off-set and will reflect in the fee we agree with you. When you first instruct us, we will assess the complexity of the matter and ensure that the person handling your case has the appropriate level of experience and expertise.

Our Engagement Letter will set out our terms of business including details of the person with the conduct of the matter and any other staff members who will assist. Our rates vary, depending on level of experience and urgency of the job, from £120 - £275 plus VAT per hour.

The fees set out are indicative of common categories of work we undertake and may vary depending on the complexity of the matter.

VAT

We will confirm whether VAT (at a rate of 20%) is payable at the time of instructions. There may be occasions when VAT is not applicable on a particular type of application.

Legal Fees

The fees mentioned below are based on the estimated total number of hours the matter is likely to take. The fee may vary depending on the complexity of the matter and the nature of your instructions to us.

Disbursements

Disbursements are costs related to your matter that are payable to third parties (e.g. visa application fee, Immigration Health Surcharge, Immigration Skills Charge, etc). The fee payable to the Home Office (UK Visas and Immigration) varies depending on the category of the application.

The Home Office introduced the Immigration Health Surcharge (IHS) in April 2015, which increased to £624 per year in October 2020. The IHS is payable by applicants applying for leave to enter or leave to remain in the UK for a period exceeding 6 months. The fee is payable prior to submission of the application and is paid in advance to cover the duration of the visa. Migrants are entitled to access the NHS upon approval of the application.
